# **Management Discussion of Fund Performance**

June 6, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the year ended March 31, 2024 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

## **Investment Objective and Strategies**

The Fund intends to provide investors with long-term capital appreciation through a globally diversified portfolio solution. The Fund aims to achieve this by investing substantially all of its assets primarily in the securities of Underlying Funds and other investment funds believed to be supportive of the United Nation's Sustainable Development Goals (SDGs), with a primary focus on climate action, combating climate change and its impacts. The Fund may also invest directly in equity securities. Based on its assessment of economic and market conditions, the Portfolio Advisor may actively shift the allocation of the Fund's exposures with respect to geography, sector, investment style, market capitalization, and/or currency. As part of the Fund's investment strategy, the Fund invests in an IG Wealth Management Fund or other investment fund managed by Mackenzie Financial Corporation, which will periodically acquire and retire carbon credits seeking to neutralize some or substantially all of the Fund's carbon footprint.

#### Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for long-term investors looking for capital appreciation with exposure to investments that are supportive of sustainable goals related to climate action who intend to have a diversified portfolio in a single investment, and who have a medium tolerance for risk.

### Results of Operations

#### **Investment Performance**

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

For the year ended March 31, 2024, the Series F securities returned 17.2% (after deducting fees and expenses paid by the Fund). In comparison, the MSCI AC (All Country) World (Net) Index returned 23.3%.

Within the MSCI AC (All Country) World (Net) Index, Poland, Colombia and Hungary were the strongest-performing markets in Canadian dollar terms, while Hong Kong, China and Thailand were the weakest. The information technology, communication services and financials sectors were the strongest performers, while consumer staples, utilities and real estate were the weakest.

The Fund underperformed the index, in part because of exposure to fixed income investments and Canadian equities.

Mackenzie Greenchip Global Environmental Equity Fund, representing about 5% of net assets at the end of the period, was the largest detractor from Fund performance. iShares ESG Advanced MSCI USA ETF, representing about 15% of net assets, was the largest contributor to performance.

#### **Environmental, Social and Governance ("ESG") Impact**

The Fund is designed to provide exposure to climate solutions via several methods. The Fund invests in managers or mandates where climate drives the investment process, resulting in exposure to companies with leading climate policies and practices, and to companies or products that are helping to advance the green transition. The Fund manages climate characteristics and is focused on holistic measures such as the United Nations Sustainable Development Goals Framework to evaluate the ESG impact of investments. Additionally, the Fund employs an offsetting strategy, which seeks to reduce the impact of any residual greenhouse gas emissions from its underlying investments. The Fund achieves this by buying and retiring carbon credits on an ongoing basis within its holding of IG Climate Action Portfolios — Betterworld Canada I. The portfolio management teams of the funds held also engage with company management and use proxy voting to prioritize climate policies and outcomes.

#### **Net Assets**

The Fund's net assets increased by 56.3% during the period to \$40.1 million. This change was composed primarily of \$5.5 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$8.9 million due to net securityholder activity (including sales, redemptions and cash distributions).

#### **Fees and Expenses**

The management expense ratio ("MER") for each series during the year ended March 31, 2024, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

### Recent Developments

Global equities rose over the period as central banks slowed the pace of interest rate increases. The global economy was resilient, and employment remained strong. Global equity markets experienced increasing valuation multiples, although gains in the U.S. equity market came largely from a small number of mega-capitalization stocks. Inflation slowed but remained slightly above central bank targets.

## Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisor provided investment services to the Fund:

Mackenzie Financial Corporation

Mackenzie Financial Corporation is a wholly owned subsidiary of IGM Financial Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Trustee is responsible for the overall direction of the affairs of the Fund. The Fund paid the Trustee a fee for its services.

See *Fund Formation and Series Information* for the annual rates paid by each series (as a percentage of average net assets) for these fees.

Securityholders in Series F and Series FT also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses.

During the period, the Fund invested in other funds also managed by the Manager or affiliates of the Manager. At March 31, 2024, the Fund had \$12.6 million (31.4% of the Fund's NAV) invested in underlying funds managed by Mackenzie. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions.

Investment, if any, in unlisted open-ended funds managed by the Manager and/or affiliates of the Manager will be in series that do not pay fees. The exchange-traded funds (ETFs) into which the Fund may invest may have their own fees and expenses which reduce the value of the ETF. Generally, the Manager has determined that fees paid by an ETF are not duplicative with the fees paid by the Fund. However, where the ETF is managed by Mackenzie Financial Corporation, the ETF may distribute a fee rebate to the Fund to offset fees paid within the ETF.


#### **Past Performance**



- (2) Management expense ratio ("MER") is based on total expenses, excluding commissions and other portfolio transaction costs, income taxes and withholding taxes, for the stated period and is expressed as an annualized percentage of daily average net assets during the period, except as noted. In the period a series is established, the MER is annualized from the date of inception to the end of the period. Where the Fund directly invests in securities of another fund (including exchange-traded funds or "ETFs"), the MERs presented for the Fund include the portion of MERs of the other fund(s) attributable to this investment. Any income distributions received from ETFs managed by affiliates of the Manager, with the intention of offsetting fees paid within those ETFs but which are not considered to be duplicative fees under regulatory requirements, are treated as waived expenses for MER purposes. The Manager may waive or absorb operating expenses at its discretion and stop waiving or absorbing such expenses at any time without notice.
- (3) The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs incurred as an annualized percentage of daily average net assets during the period. Where the Fund invests in securities of another fund (including ETFs), the TERs presented for the Fund include the portion of TERs of the other fund(s) attributable to this investment.
- (4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher the Fund's portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund. The portfolio turnover rate is not provided when the Fund is less than one year old. The value of any trades to realign the Fund's portfolio after a fund merger, if any, is excluded from the portfolio turnover rate.

#### **Management Fees**

The Fund pays a management fee, and this fee, paid by each series, is calculated as a percentage of the net asset value at the close of each business day (see *Fund Formation and Series Information* for rates payable). The management fees pay the costs incurred to provide investment management services.

Securityholders also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses. Distribution-related services were paid for out of the advisory fee and other revenue sources.
