Management Discussion of Fund Performance

November 13, 2023

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Pool's performance and outlook in the six-month period ended September 30, 2023 (the "period"). If the Pool was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Pool. In addition, net asset value ("NAV") refers to the value of the Pool as calculated for transaction purposes, on which the discussion of Pool performance is based.

Results of Operations

Investment Performance

In accordance with National Instrument 81-106, the following comparison to one or more market indices has been included to help you understand the Pool's performance relative to the general performance of the markets. However, the portfolio management team cautions that the Pool's mandate may be different from the index or indices shown. Also, it is important to note that investors cannot invest in an index. Indirect investments in an index are available; however, there are fees and transaction costs and other variables that will impact returns when investing in these products. Index returns included in the comparison below do not reflect these costs and variables. In addition, unlike the index, this Pool may be subject to valuation adjustments as outlined in the Pool's valuation policies as it relates to non-North American equities held either directly or indirectly by the Pool. A fair value adjustment can either positively or negatively impact the Pool's rate of return.

For the returns of all series and for longer-term performance of the Pool, see the *Past Performance* section of this report. Performance will vary by series primarily because fees and expenses may differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. See *Series Information* for the annual expense rates for each series.

For the six-month period ended September 30, 2023, the Series I securities returned -2.1% (after deducting fees and expenses paid by the Pool). In comparison, the S&P/TSX Composite Index returned -1.1%.

Canadian equities declined over the period, driven lower by rising interest rates and slowing economic growth. Elevated inflation persisted, which prompted the Bank of Canada to raise its policy interest rate. Canadian energy equities benefited from the production cuts made by the Organization of the Petroleum Exporting Countries, which kept energy prices relatively high. The labour market was robust but showed signs of softening as the period progressed.

Within the S&P/TSX Composite Index, health care, energy and information technology were the strongest sectors, while communication services, utilities and materials were the weakest.

The Pool underperformed the index, with underweight exposure to the energy sector and stock selection in the information technology sector detracting from performance. Underweight exposure to the utilities sector and stock selection in the financials sector contributed to performance. Holdings in the United States also contributed to performance.

Over the period, neither portfolio activity nor market developments significantly changed the positioning of the Fund.

Net Assets

The Pool's net assets decreased by 1.5% during the period to \$7.3 billion. This change was composed primarily of \$154.0 million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$40.3 million due to net securityholder activity (including sales, redemptions and cash distributions).

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2023, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

The portfolio management team believes that economic growth will moderate in the final months of 2023 and into 2024. Inflation is expected to continue to slow into 2024 but remain in a range of 3% to 4%. The team believes bond yields have likely peaked as most global central banks, including the Bank of Canada, have paused or ended their interest rate hikes. However, the team expects a "soft-landing" recession as previous interest rate increases continue to work through the economy, with a strong labour market countering weakness. Slower growth in China could further reduce economic performance in Canada and the United States.

In this environment, the team believes equity returns could be weighed down by weaker earnings growth as high wages, interest rates and materials costs squeeze profit margins, even amid signs that current recessionary conditions in housing and manufacturing may be abating. With equity valuations in Canada, Europe and emerging markets near multi-decade lows relative to U.S. valuations, the team believes there is greater potential for valuation increases in international and Canadian markets than in U.S. markets as conditions improve. In the team's view, equities in Canada are more attractive than U.S. equities, based on their historical relationship. Elevated inflation lasting longer than initially expected could put upward pressure on bond yields and downward pressure on equity market valuations, with Canadian stocks at greater risk should oil prices weaken.

Other Developments

With the approval of the IG Wealth Management Funds Independent Review Committee, iProfile™ Canadian Equity Private Class merged into the Pool on May 19, 2023. The Manager does not consider this merger to be a material change for the Pool's investors.

Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Pool. The Pool is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisors provided investment services to the Pool:

- Mackenzie Financial Corporation

Mackenzie Financial Corporation is a wholly owned subsidiary of IGM Financial Inc.

The Pool paid a pool advisory fee to the Portfolio Advisor for investment management and portfolio advisory services (see *Management Fees*).

The Pool also paid the Manager an administration fee for administrative services.

The Trustee is responsible for the overall direction of the affairs of the Pool. The Pool paid the Trustee a fee for its services.

Securityholders in Series F also pay an advisory fee directly to the Distributors. This fee is not included in the Pool's expenses.

During the period, the Pool invested in other funds also managed by the Manager or affiliates of the Manager. At September 30, 2023, the Pool had \$97.0 million (1.3% of the Fund's NAV) invested in underlying funds managed by Mackenzie. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions.

Investment, if any, in unlisted open-ended funds managed by the Manager and/or affiliates of the Manager will be in series that do not pay fees. The exchange-traded funds (ETFs) into which the Pool may invest may have their own fees and expenses which reduce the value of the ETF. Generally, the Manager has determined that fees paid by an ETF are not duplicative with the fees paid by the Pool. However, where the ETF is managed by Mackenzie Financial Corporation, the ETF may distribute a fee rebate to the Pool to offset fees paid within the ETF.

During the period, the Pool received \$0.03 million in income distributions from investments in ETFs managed by the sub-advisor to offset fees paid within the ETFs. There is no assurance that these distributions will continue in the future.

IGM Financial Inc. is a subsidiary of Power Corporation of Canada. Companies related to Power Corporation of Canada are therefore considered affiliates of the Manager. As at September 30, 2023, the Pool held the following investments in companies affiliated with the Manager: common shares of Power Corporation of Canada valued at \$21.2 million and common shares of Great-West Lifeco Inc. valued at \$2.5 million. The Manager relied on the standing instructions approved by the IG Wealth Management Funds Independent Review Committee for investment in related issuers. These investments represented, in aggregate, 0.3% of the Pool's net assets.

At September 30, 2023, the Pool held an investment of \$8.6 million (0.1% of the Pool's NAV) in Northleaf Growth Fund (Canada) LP, a private fund managed by Northleaf Capital Partners, a company affiliated with the Manager. This represents US\$6.8 million as part of a total commitment to invest US\$50.0 million. In making the investment(s), the Manager relied on a positive recommendation previously issued by the IG Wealth Management Funds' Independent Review Committee.

At September 30, 2023, the Pool held an investment of \$8.6 million (0.1% of the Pool's NAV) in Sagard Private Equity Canada LP, a private fund managed by Sagard Holdings Inc., a company affiliated with the Manager. This represents \$9.9 million as part of a total commitment to invest \$60.0 million. In making the investment(s), the Manager relied on a positive recommendation previously issued by the IG Wealth Management Funds' Independent Review Committee.

Certain other investment funds, distributed by IG Wealth Management, and other qualified investors may invest in Series P of this Pool. As at September 30, 2023, this series comprised approximately 11.9% of the Pool's net assets. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions, which are based on the net asset value per security determined in accordance with the stated policies of the Pool on each transaction day. Investments by other investment funds in the Pool increase the risk of large redemption or purchase orders, which could result in larger than normal cash positions in the Pool for short periods of time. This could have an impact on the Pool's operations. However, the Manager uses various strategies to minimize the potential dilutive impact associated with large cash positions. These strategies may include transferring securities in-kind where possible, utilizing ETFs to maintain market exposure in lieu of cash and spreading transactions in smaller increments over a period of time.

The Manager relied on an approval issued by the IG Wealth Management Funds Independent Review Committee to proceed with the merger of iProfile™ Canadian Equity Private Class into the Pool on May 19, 2023.

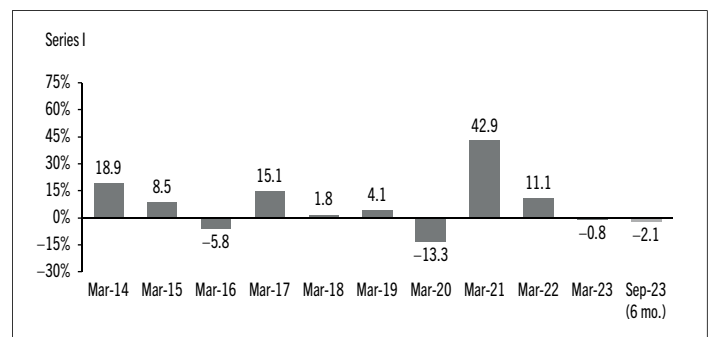
Past Performance

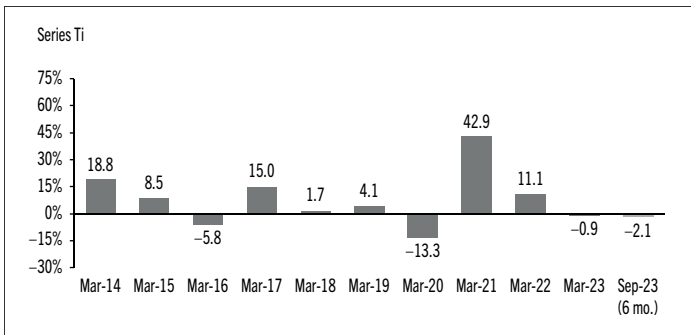
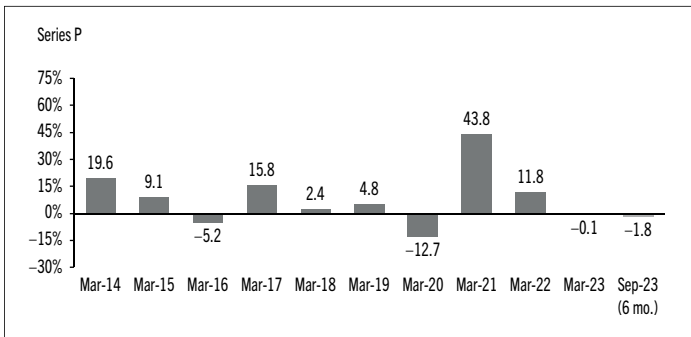
Year-by-Year Returns

Management Fees

The Pool pays a pool advisory fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see *Series Information* for rates payable by each series). The pool advisory fees pay the costs incurred to provide investment management services.

Securityholders in the iProfile Program also pay a program advisory fee directly to the Distributors. This fee is not included in the Pool's expenses. Distribution-related services were paid for out of the program advisory fee and other revenue sources.
