Management Discussion of Fund Performance

November 13, 2023

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the six-month period ended September 30, 2023 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Please read *A Note on Forward-Looking Statements* on the first page of this document.

On February 16, 2023, the IG Wealth Management Funds' Independent Review Committee approved a proposal to wind up Investors Group Corporate Class Inc. and merge its suite of Corporate Class funds into corresponding trust fund equivalents because it was in a taxable position. As a result, investors holding securities of IG Mackenzie Global Natural Resources Class (the "Predecessor Fund") were merged into the corresponding series of the Fund on a tax-deferred basis on May 19, 2023. The fees, the investment objective and strategies, and the portfolio management team of the Fund are substantially similar to those of the Predecessor Fund. Consequently the information in this report is presented as if the Fund had existed since the inception of the Predecessor Fund.

Effective on May 19, 2023, all series of the Fund are closed to any new investment.

Results of Operations

Investment Performance

In accordance with National Instrument 81-106, the following comparison to one or more market indices has been included to help you understand the Fund's performance relative to the general performance of the markets. However, the portfolio management team cautions that the Fund's mandate may be different from the index or indices shown. Also, it is important to note that investors cannot invest in an index. Indirect investments in an index are available; however, there are fees and transaction costs and other variables that will impact returns when investing in these products. Index returns included in the comparison below do not reflect these costs and variables. In addition, unlike the index, this Fund may be subject to valuation adjustments as outlined in the Fund's valuation policies as it relates to non-North American equities held either directly or indirectly by the Fund. A fair value adjustment can either positively or negatively impact the Fund's rate of return.

For the returns of all series and for longer-term performance of the Fund, see the *Past Performance* section of this report. Performance will vary by series primarily because fees and expenses may differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. See *Series Information* for the annual expense rates for each series.

For the six-month period ended September 30, 2023, the Series F securities returned 4.8% (after deducting fees and expenses paid by the Fund). In comparison, the Fund's broad-based index, the MSCI World (Net) Index, returned 3.5% and the Fund's blended index returned 4.4%. The blended index is composed of a 55% weighting in the MSCI World Energy (Net) Index (returned 11.1%) and a 45% weighting in the MSCI World Materials (Net) Index (returned -3.6%). Given the Fund's mandate, the blended index has been included as a more meaningful comparison.

Global equities rose over the period as central banks slowed the pace of their rate increases. The global economy proved resilient, and employment remained strong. With high inflation persisting, the U.S. Federal Reserve, European Central Bank and Bank of England increased their policy interest rates, albeit at a slower pace. Higher interest rates and inflation contributed to tight financial conditions, which weighed on demand and hindered manufacturing sector activity.

Within the MSCI World (Net) Index, Norway, Italy and the United States were the strongest-performing markets in Canadian dollar terms, while Hong Kong, New Zealand and Finland were the weakest. The communication services, energy and information technology sectors were the strongest performers, while utilities, consumer staples and real estate were the weakest.

Commodity prices remained volatile over the period. Geopolitical tensions, moderating demand and central banks pausing their interest rate increases all weighed on commodity prices. However, the price of oil rose, benefiting from production cuts from the Organization of the Petroleum Exporting Countries. Natural gas prices also rose, driven by relatively strong demand. Conversely, gold prices fell as the U.S. dollar appreciated and interest rates were expected to remain high for longer than previously thought.

The Fund outperformed the broad-based index, with overweight exposure to the energy sector contributing to performance, while overweight exposure to the materials sector detracted from performance.

The Fund outperformed the blended index, with stock selection in Canada and holdings in Brazil contributing to performance. In industry terms, stock selection in oil, gas and consumable fuels and underweight exposure to chemicals contributed to performance. Underweight exposure to the United States and holdings in South Africa detracted from performance. In industry terms, stock selection in metals and mining and in paper and forest products detracted from performance.

Over the period, the Fund's exposure to the oil, gas and consumable fuels industry increased, while exposure to the metals and mining industry decreased, based on the portfolio management team's assessment of valuations and opportunities, and as a result of market movements.

Net Assets

The Fund's net assets decreased by 4.8% during the period to \$78.4 million. This change was composed primarily of \$3.6 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of \$7.6 million due to net securityholder activity (including sales, redemptions and cash distributions).

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2023, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

While commodity prices have come down from peak levels, the portfolio management team expects them to remain well above the lows reached in previous cycles. For commodities such as copper, this trend is already evident.

The team believes the next decade will be about infrastructure rebuilding, onshoring production and the material-intensive energy transition. This shift should allow commodity prices to stabilize at higher levels than expected by current market consensus. Higher prices should be reflected in upward equity revaluations – which the team views as the ultimate signal for company executives to redeploy capital and address climate change.

Other Developments

With the approval of the IG Wealth Management Funds Independent Review Committee, the Predecessor Fund merged into the Fund on May 19, 2023.

Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisor provided investment services to the Fund:

- Mackenzie Financial Corporation

Mackenzie Financial Corporation is a wholly owned subsidiary of IGM Financial Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Fund paid the Distributors a service fee as compensation for providing or arranging for the provision of services to the Fund, including the issue or allotment of securities.

The Trustee is responsible for the overall direction of the affairs of the Fund. The Fund paid the Trustee a fee for its services.

See *Series Information* for the annual rates paid by each series (as a percentage of average net assets) for these fees.

Securityholders in Series F also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses.

During the period, the Fund invested in other funds also managed by the Manager or affiliates of the Manager. At September 30, 2023, the Fund had \$10.8 million (13.8% of the Fund's NAV) invested in underlying funds managed by Mackenzie. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions.

Investment, if any, in unlisted open-ended funds managed by the Manager and/or affiliates of the Manager will be in series that do not pay fees. The exchange-traded funds (ETFs) into which the Fund may invest may have their own fees and expenses which reduce the value of the ETF. Generally, the Manager has determined that fees paid by an ETF are not duplicative with the fees paid by the Fund. However, where the ETF is managed by Mackenzie Financial Corporation, the ETF may distribute a fee rebate to the Fund to offset fees paid within the ETF.

The Manager relied on an approval issued by the IG Wealth Management Funds Independent Review Committee to proceed with the merger of the Predecessor Fund into the Fund on May 19, 2023.

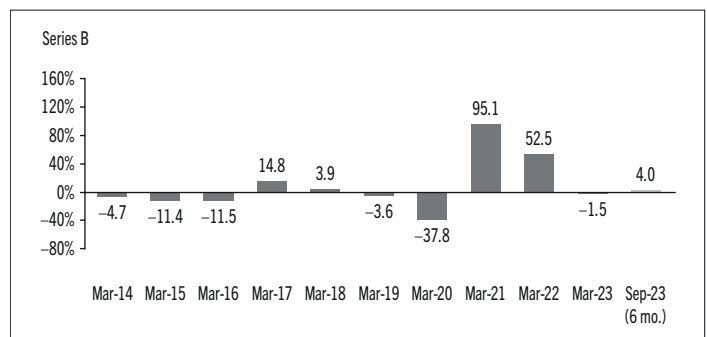

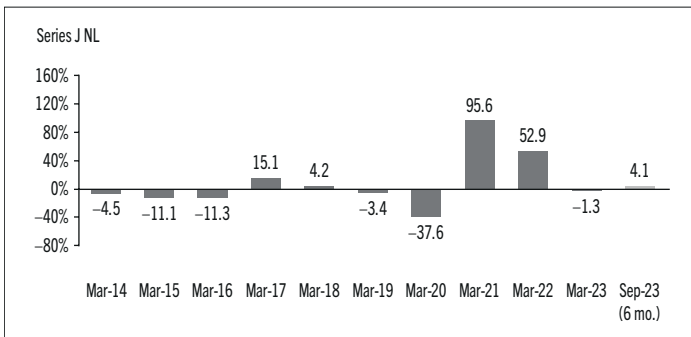
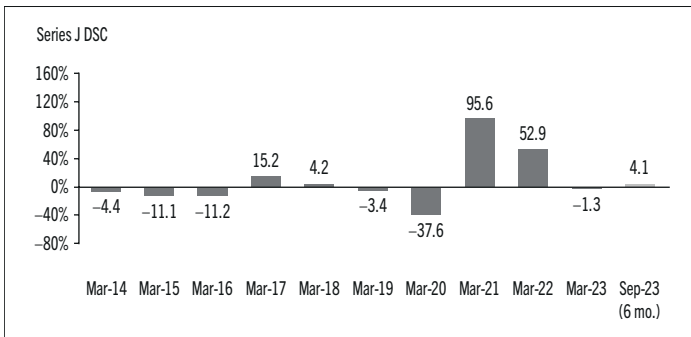
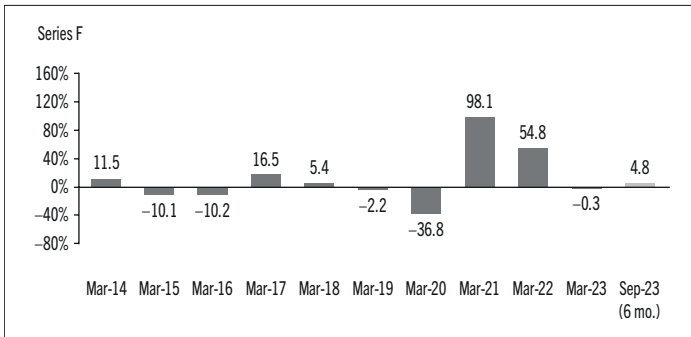
Year-by-Year Returns

Management Fees

The Fund pays a management fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see *Series Information* for rates payable by each series). Generally, management fees pay the costs incurred to provide investment advisory and management services, as well as distribution-related services provided by the Distributors.

However, in the case of Series F, securityholders pay the Distributor an advisory fee (separate from the management fee) directly. Therefore, the management fee in that series is used for investment advisory and management services only.

For all other retail series (i.e. those that exclude Series R, P and S, if issued), approximately 65% of management fees paid during the period was used for investment advisory and management services, and approximately 35% related to distribution-related services. This may vary by series.
