

Management Discussion of Fund Performance

November 13, 2023

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the six-month period ended September 30, 2023 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Please read A Note on Forward-Looking Statements on the first page of this document.

On February 16, 2023, the IG Wealth Management Funds' Independent Review Committee approved a proposal to wind up Investors Group Corporate Class Inc. and merge its suite of Corporate Class funds into corresponding trust fund equivalents because it was in a taxable position. As a result, investors holding securities of IG Mackenzie U.S. Opportunities Class (the "Predecessor Fund") were merged into the corresponding series of the Fund on a tax-deferred basis on May 19, 2023. The fees, the investment objective and strategies, and the portfolio management team of the Fund are substantially similar to those of the Predecessor Fund. Consequently the information in this report is presented as if the Fund had existed since the inception of the Predecessor Fund.

Effective on May 19, 2023, all series of the Fund are closed to any new investment.

Results of Operations

Investment Performance

In accordance with National Instrument 81-106, the following comparison to one or more market indices has been included to help you understand the Fund's performance relative to the general performance of the markets. However, the portfolio management team cautions that the Fund's mandate may be different from the index or indices shown. For a description of the index or indices, see *Annual Compound Returns*. Also, it is important to note that investors cannot invest in an index. Indirect investments in an index are available; however, there are fees and transaction costs and other variables that will impact returns when investing in these products. Index returns included in the comparison below do not reflect these costs and variables.

For the returns of all series and for longer-term performance of the Fund, see the *Past Performance* section of this report. Performance will vary by series primarily because fees and expenses may differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. See *Series Information* for the annual expense rates for each series.

For the six-month period ended September 30, 2023, the Series F securities returned -1.5% (after deducting fees and expenses paid by the Fund). In comparison, the Fund's broad-based index, the S&P 500 Index, returned 5.6% and the Fund's narrow index, the Russell 2500 Index, returned 0.6%. Given the Fund's mandate, the narrow index has been included as a more meaningful comparison.

U.S. equities rose over the period as the pace of interest rate increases eased. U.S. consumer spending remained relatively strong despite tight financial conditions. The U.S. labour market was strong and inflation remained elevated. In response, the U.S. Federal Reserve continued to raise its federal funds rate, albeit at a slower pace. Large-capitalization growth stocks outperformed value stocks as interest rate increases were expected to slow.

Within the S&P 500 Index, communication services, energy and information technology were the strongest sectors in Canadian dollar terms, while utilities, real estate and consumer staples were the weakest.

U.S. small-capitalization and mid-capitalization stocks generally underperformed large-capitalization stocks. Within the Russell 2500 Index, energy, industrials and financials were the strongest sectors in Canadian dollar terms, while utilities, communication services and health care were the weakest.

As at September 30, 2023, substantially all the net assets of the Fund were invested in IG Mackenzie U.S. Opportunities Fund (the Underlying Fund).

The Underlying Fund underperformed both the broad-based index and the narrow index, with stock selection in the information technology sector detracting from performance.

Relative to the broad-based index, stock selection in the health care and consumer discretionary sectors also detracted from performance, while stock selection in financials and an underweight position and stock selection in consumer staples contributed to performance.

Relative to the narrow index, lack of exposure to the energy sector also detracted from performance, while stock selection in real estate and lack of exposure to utilities contributed to performance.

Over the period, neither portfolio activity nor market developments significantly changed the positioning of the Underlying Fund.

Net Assets

The Fund's net assets increased by 45.6% during the period to \$126.3 million. This change was composed primarily of \$1.2 million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$40.8 million due to net securityholder activity (including sales, redemptions and cash distributions). The securityholder activity includes an inflow of \$50.7 million relating to fund merger activity (see *Recent Developments*).

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2023, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

In the view of the Underlying Fund's portfolio management team, the events of the last few years have exacerbated structural challenges to the U.S. economy in the form of high debt levels and low growth in the working-age population. Over the period, the team took advantage of a declining market by adding back holdings in higher-growth businesses whose valuations became more attractive in an environment of labour shortages, rising inflation and tighter monetary policy. The team maintained a focus on companies that use intellectual property, data and technology to enhance productivity for themselves and their customers.

Other Developments

With the approval of the IG Wealth Management Funds Independent Review Committee, the Predecessor Fund merged into the Fund on May 19, 2023.

Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

Mackenzie Financial Corporation is a wholly owned subsidiary of IGM Financial Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Fund paid the Distributors a service fee as compensation for providing or arranging for the provision of services to the Fund, including the issue or allotment of securities.

The Trustee is responsible for the overall direction of the affairs of the Fund. The Fund paid the Trustee a fee for its services.

See *Series Information* for the annual rates paid by each series (as a percentage of average net assets) for these fees.

Securityholders in Series F also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses.

During the period, the Fund invested substantially all of its assets in another IG Wealth Management Fund. There is no duplication of fees incurred by the Fund in connection with these investments.

The Manager relied on an approval issued by the IG Wealth Management Funds Independent Review Committee to proceed with the merger of the Predecessor Fund into the Fund on May 19, 2023.







Management Fees

The Fund pays a management fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see Series Information for rates payable by each series). Generally, management fees pay the costs incurred to provide investment advisory and management services, as well as distribution-related services provided by the Distributors.

However, in the case of Series F, securityholders pay the Distributor an advisory fee (separate from the management fee) directly. Therefore, the management fee in that series is used for investment advisory and management services only.

For all other retail series (i.e. those that exclude Series R, P and S, if issued), approximately 65% of management fees paid during the period was used for investment advisory and management services, and approximately 35% related to distribution-related services. This may vary by series.
